

HER TIME TOYOTA GIVEAWAY CONTEST

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

Void outside of Utah and where prohibited by law. The Official Rules create obligations on your part, including indemnities to third parties by you and limitations on your rights and remedies, so please read them carefully before entering.

ELIGIBILITY: The HER Time Toyota Giveaway Contest (the “Contest”) is open to legal residents of the State of Utah, who are 18 years of age or older, who are licensed drivers, and who coach girls youth sports and/or who provides mentorship to a girls youth group in their respective community. Employees of Denver Region Toyota Dealers Advertising Group, Inc. (“Sponsor”), Jazz Basketball Investors LLC dba Utah Jazz (“Administrator”), Toyota Motor Sales USA, Inc, The National Basketball Association, the NBA Member Teams, NBA Media Ventures, LLC, NBA TV, LLC and NBA Enterprises, LLC (collectively, “NBA Entities”), and each of their respective parents, affiliates, subsidiaries, franchisees, retailers and advertising and promotion agencies, as well as the immediate family (spouse, parents, siblings, children and each of their respective spouses, regardless of where they reside) and household members of each such employee, whether related or not, are not eligible to enter or win. The Contest is governed by Utah law and is subject to all applicable federal, state, and local laws and regulations.

CONTEST PERIOD: The Contest begins at 12:00 a.m. Mountain Standard Time (“MST”) on October 22, 2025 and ends at 11:59 p.m. MST on March 1, 2026 (the “Contest Period”). Administrator’s computer system clock will be understood as the official timekeeper of the Contest.

HOW TO ENTER: During the Contest Period, visit <https://www.nba.com/jazz/community/hertime> and follow the instructions to complete the entry form for the Contest. Entries must be received by 11:59 p.m. MST on March 1, 2026, to be eligible. Limit of one (1) entry per person using only one valid email address for the entire Contest Period. Entries received in excess of the above stated limitation from any person or email address will be void. All entries become the property of Administrator and will not be acknowledged or returned. Entries generated by script, macro or other automated means and entries by any means which subvert the entry process will be void. In the event of a dispute as to who submitted an entry, the authorized account holder of the email address used to participate will be deemed to be the entrant and must comply with these Official Rules. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Multiple entrants are not permitted to share the same email address. Potential winners may be required to show proof of being the authorized account holder. If a dispute over the identity of an entrant cannot be resolved to Administrator’s satisfaction, the affected entry(ies) will be disqualified.

REQUIREMENTS OF ENTRIES: Entry must be the original work of the entrant, may not have been previously published, may not have won previous awards, and must not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity.

Entry may not contain, as determined by the Sponsor, in its sole discretion, any content that:

- is sexually explicit or suggestive, is unnecessarily violent, is derogatory, or is profane or pornographic;
- promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), promotes any activities that may appear unsafe or dangerous, or promotes any particular political agenda or message;
- is obscene or offensive or endorses any form of hate or hate group;
- appears to duplicate any other submitted Entries;
- defames, misrepresents or contains disparaging remarks about Sponsor, Administrator, their respective products or services, or other people or companies;
- contains trademarks or logos owned by others, without permission, to the extent permission is necessary;
- contains any personal identification, such as license plate numbers, personal names, e-mail addresses or street addresses;
- contains copyrighted materials owned by others, without permission, to the extent the permission is necessary;
- contains materials embodying the names or other indicia identifying any person, living or dead, without permission;
- communicates messages or images inconsistent with the positive images and/or good will to which the NBA Entities wish to associate; or
- violates applicable law.

Sponsor, in its sole discretion, may disqualify your entry for any reason, including if it determines that your entry fails to conform to these Official Rules in any way or otherwise contains unacceptable content.

WINNER DETERMINATION: Following the conclusion of the Contest Period, all eligible entries received will be judged by a panel of qualified judges based on the following equally weighted criteria: (1) a commitment of service to their community as a coach of girls youth sports and/or as a mentor to a girls youth group in their respective community as demonstrated through their entry, and (2) explanation as to why the prize will enhance their commitment of service (the “Criteria”). The entrant who submits the entry that receives the highest score will be deemed the potential winner. In the event of a tie, a tie breaker judge will judge the tied entries using the Criteria to determine the winner. Sponsor reserves the right to not award the prize if, in its sole discretion, it does not receive a sufficient number of eligible and qualified entries. All decisions of the Sponsor and judges are final and binding. Sponsor will not reveal the judging scores for any entry.

WINNER NOTIFICATION: The potential winner will be notified via email and will be required to execute and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within five (5) days of date of issuance. If such documents are not returned within the specified time period, prize notification is returned as undeliverable, Administrator is unable to contact a potential winner or a potential winner is not in compliance with these Official Rules, prize will be forfeited and, at Administrator’s discretion, a runner-up may be notified.

PRIZE: VIP Jazz experience and equipment grant. Winner will be fully responsible for all applicable federal, state and local taxes. Winner must accept delivery at a later date.

Prize is non-transferrable and cannot be substituted. Sponsor is not responsible for and will not pay or in any way compensate winner for taxes associated with winning a prize. Winner will be required to provide winner’s Social Security Number to the Administrator before receiving the prize. If required by law, the Sponsor and/or Administrator will issue Form 1099-MISC to the winner reporting the taxable retail value of the prize. Winner should consult winner’s tax advisor about the tax implications of accepting a prize package. All prize details are at Sponsor’s sole discretion.

CONDITIONS OF ENTRY: By participating, each entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of Sponsor and Administrator, which are final and binding in all matters related to the Contest. Administrator reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules, or in an unsportsmanlike or disruptive manner and void all associated entries.

PUBLICITY GRANT/USE OF ENTRIES: By submitting an entry, each entrant waives all moral rights in and to the entry and grants to Sponsor, Administrator, and their respective licensees, successors and assigns an irrevocable, perpetual, unlimited, royalty-free, fully paid-up license to reproduce, distribute, display, exhibit, exploit, perform, edit, create derivatives of, and otherwise use the entry and all elements of such entry, together with any other material, and the name, city and state of residence, voice, image and/or likeness of entrant, in any and all media now known or hereafter devised, in any manner, in whole or in part, worldwide, without compensation or notification to, or permission from, entrant or any third party, for any purposes whatsoever, including without limitation, for purposes of advertising or trade. Entrant agrees that, if required by Sponsor, winner will sign documents to this effect. Releasees (as defined below) are not responsible for any unauthorized use of entries by third parties. Sponsor and Administrator have no obligation to make use of the rights granted herein.

LIMITATIONS OF LIABILITY: Entrants agree to release and hold harmless Sponsor, Administrator, NBA Entities, and their respective parent companies, affiliates, subsidiaries, franchisees, divisions, suppliers, distributors, retailers, and advertising and promotion agencies, and all of their respective officers, directors, partners, equity holders, employees, and agents (collectively, "Releasees") from any and all claims, actions, injury, liability, loss or damage of any kind resulting from participating in this Contest or from the acceptance or use of prize awarded (including any injury or harm resulting from use of the prize). Releasees are not responsible for: (1) technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware or software; (2) the unavailability or inaccessibility of any transmissions or cable, satellite, telephone or Internet service; (3) unauthorized human intervention in any part of the entry process of the Contest; (4) late, lost, undelivered, misdirected, delayed, damaged, inaccurate, garbled or incomplete entries, email addresses, emails, or other communications of any kind; (5) any electronic, computer, printing, typographical, human or other error relating to or in connection with the Contest, including, without limitation, errors which may occur in connection with the administration of the Contest, the processing or judging of entries, the announcement of the prize, or in any Contest-related materials (including these Official Rules); or (6) any injury or damage to persons or property, including but not limited to entrant's computer, other device, hardware, or software, which injury or damage may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest. In such event, Administrator reserves the right to award the prize from among all eligible, non-suspect entries received up to the time of such impairment using the judging procedure outlined above or as otherwise deemed fair and appropriate by Sponsor. Any attempt to deliberately damage or undermine the legitimate operation of the Contest may be in violation of criminal and civil laws and will result in disqualification from participation in the Contest. Should such an attempt be made, Administrator reserves the right to seek remedies and damages (including, without limitation, attorneys' fees) to the fullest extent of the law, including, without limitation, criminal prosecution.

ARBITRATION: Except where prohibited by law, as a condition of participating in this Contest, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this Contest, or any prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest the entrant; (2) the Federal Arbitration Act shall govern the interpretation,

enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including, without limitation, attorneys' fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with participating in this Contest), and entrant further waives all rights to have damages multiplied or increased.
