

Utah Jazz X Arena Experience Giveaway Official Rules

No purchase necessary to enter or win. A purchase does not improve your chances of winning. Odds of winning will depend on the total number of entries received. Void where prohibited by law. The official rules create obligations on your part, including indemnities to third parties by you and limitations on your rights and remedies, so please read them carefully before entering.

ELIGIBILITY: The **Arena Experience Giveaway** is open to legal residents of the State of Utah who are 18 years of age or older at the time of entry. Employees of Jazz Basketball Investors LLC dba Utah Jazz, ("Administrator"), and NBA Entities, and each of their respective parents, affiliates, subsidiaries, franchisees, retailers and advertising and Sweepstakes agencies, as well as the immediate family (spouse, parents, siblings, children and each of their respective spouses, regardless of where they reside) and household members of each such employee, whether related or not, are not eligible to enter or win. Entries must be received by **11:59 P.M. MST on Feb. 5th, 2026**, to be eligible. Limit of one entry per person using only one valid phone number throughout the Sweepstakes Period. Entries received in excess of the above stated limitation from any person or email address will be void. All entries become the property of the Administrator and will not be acknowledged or returned. Entries generated by script, macro or other automated means and entries by any means which subvert the entry process will be void. In the event of a dispute as to who submitted an entry, the authorized account holder of the email address used to participate will be deemed to be the entrant and he/she must comply with these Official Rules. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address.
