

## Utah Jazz X Tagg-N-Go Giveaway Official Rules

No purchase necessary to enter or win. A purchase does not improve your chances of winning. Odds of winning will depend on the total number of entries received. Void where prohibited by law. The official rules create obligations on your part, including indemnities to third parties by you and limitations on your rights and remedies, so please read them carefully before entering.

**ELIGIBILITY:** The **Tagg-N-Go Giveaway** is open to legal residents of the State of Utah who are 18 years of age or older at the time of entry. Employees of Jazz Basketball Investors LLC dba Utah Jazz, (“Administrator”), and NBA Entities, and each of their respective parents, affiliates, subsidiaries, franchisees, retailers and advertising and Sweepstakes agencies, as well as the immediate family (spouse, parents, siblings, children and each of their respective spouses, regardless of where they reside) and household members of each such employee, whether related or not, are not eligible to enter or win. The Sweepstakes is governed by Utah law and is subject to all applicable federal, state, and local laws and regulations.

**HOW TO ENTER:** During the Sweepstakes Period, visit <https://www.nba.com/jazz/text-list> and follow the instructions to complete the entry form for the Sweepstakes. Entries must be received by **11:59 P.M. MST on Mar. 13, 2026**, to be eligible. Limit of one entry per person using only one valid phone number throughout the Sweepstakes Period. Entries received in excess of the above stated limitation from any person or email address will be void. All entries become the property of the Administrator and will not be acknowledged or returned. Entries generated by script, macro or other automated means and entries by any means which subvert the entry process will be void. In the event of a dispute as to who submitted an entry, the authorized account holder of the email address used to participate will be deemed to be the entrant and he/she must comply with these Official Rules. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Multiple entrants are not permitted to share the same phone number. Potential winners may be required to show proof of being the authorized account holder. If a dispute over the identity of an entrant cannot be resolved to Administrator’s satisfaction, the affected entry(ies) will be disqualified.

**WINNER NOTIFICATION:** The potential winners will be notified via text and may be required to execute and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within five days of date of issuance. If such documents are not returned within the specified time period, prize notification is returned as undeliverable, Administrator is unable to contact a potential winner if a potential winner is not in compliance with these Official Rules, prize will be forfeited and, at Administrator's discretion, alternate winners may be selected.

In such an event, the administrator reserves the right to award the prize in a random drawing from among all eligible, non-suspect entries received up to the time of such impairment. Any attempt to deliberately damage or undermine the legitimate operation of the Sweepstakes may be in violation of criminal and civil laws and will result in disqualification from participation in the Sweepstakes. Should such an attempt be made, the Administrator reserves the right to seek remedies and damages (including attorney fees) to the fullest extent of the law, including criminal prosecution.
